DISCUSSION ITEMS:

Ordinance 1819-2022 – 2022 Property Tax Rate

Attorney Greg Voss read in summary Ordinance 1819-2022 for the Second Reading.

AN ORDINANCE OF THE CITY OF ELSMERE, KENTON COUNTY, KENTUCKY, PROVIDING FOR ASSESSMENT OF ALL REAL ESTATE AND PERSONAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF ELSMERE THAT IS SUBJECT TO TAXATION FOR CITY PURPOSES BY THE USE OF THE ANNUAL COUNTY ASSESSMENT THEREOF BY THE PROPERTY VALUATION ADMINISTRATOR OF KENTON COUNTY; AND, LEVYING AN AD VALOREM TAX THEREON FOR THE CITY'S PURPOSES DURING THE FISCAL YEAR WHICH BEGINS JULY 1, 2022 AT THE RATE OF \$0.195 DOLLARS FOR EACH ONE HUNDRED SO ASSESSED OF REAL PROPERTY, AND AT THE RATE OF \$ 0.260 DOLLARS FOR EACH ONE HUNDRED SO ASSESSED OF PERSONAL PROPERTY, AND AT THE RATE OF \$.132 FOR EACH ONE HUNDRED DOLLARS ASSESSED ON ALL TAXABLE PROPERTY FOR STREET TAX PURSUANT TO ORDINANCE 1570-2007; AND PROVIDING FOR PAYMENT AND COLLECTION OF SUCH TAXES AND PENALTIES AND INTEREST THEREON; AND DESCRIBING THE PURPOSES FOR WHICH SUCH TAXES SO COLLECTED SHALL BE APPROPRIATED AND USED.

Councilwoman Nancy Bowman made a motion to approve Ordinance 1819-2022 as read. Councilwoman Joanne Barnett Smith seconded the motion. All members present voted yest. **Motion Carried.**


