REQUEST FOR BIDS/PROPOSALS: TERMS AND CONDITIONS

- 1. **AUTHORITY -** This Request for Bids/Proposals is issued pursuant to applicable provisions of the City of Elsmere ("Elsmere") Code of Ordinances and the Kentucky Revised Statutes.
- BID/PROPOSAL OPENING Sealed bids/proposals will be received at the Elsmere City Building, 3921 Dixie Highway, Elsmere, KY 41018 until the date and time specified, at which time they shall be opened in public. Absent extenuating circumstances (at which time the City of Elsmere will evaluate accepting the late bid on a case-by-case basis), late bids/proposals will be rejected and returned unopened to the sender. Elsmere is not responsible for any delay, regardless of the reason, in transmission of any bids/proposals. Facsimile bids/proposals will not be accepted.
- 3. **BID/PROPOSAL PREPARATION** Bids/Proposals must be submitted with the bid/proposal form provided and all information and certifications called for must be furnished. Bids/Proposals submitted in any other manner, or which fail to furnish all information or certificates required, may be summarily rejected at the sole discretion of the City of Elsmere. Bids may be modified or withdrawn prior to the time specified for the opening of bids/proposals. Bids/Proposals shall be filled out legibly in ink or typewritten with all erasures, strikeovers and corrections initialed in ink by the person signing the bid. The bid shall include the legal name of the bidder, the complete mailing address, and be signed in blue ink by a person or persons legally authorized to bind the bidder/offeror to a contract. Name of person signing should be typed or printed below the signature.
- 4. **BID/PROPOSAL ENVELOPES** Envelopes containing bids/proposals must be sealed and addressed to the City of Elsmere Public Works. The title of the bid/proposal as specified in the RFB/RFP document must be shown on the outside of the envelope.
- 5. **ERRORS IN BIDS/PROPOSALS** Bidders/Offerors are cautioned to verify their bids/proposals before submission. Negligence on the part of the bidder/offeror in preparing the bid/proposal confers no right for withdrawal or modification of the bid/proposal after it has been opened. In case of error in the extension of prices in the bid/proposal, the unit prices will govern. All price extensions are to be checked by the buyer to ensure the total bid/proposal is accurate. Elsmere reserves the right to waive any errors or omissions contained in bids/proposals, and to waive any other irregularities, if such action benefits the City of Elsmere.
- 6. **RESERVED RIGHTS** The City of Elsmere reserves the right at any time and for any reason to cancel this Request for Bids/Proposals for any reason, accept or reject any or all bids/proposals or any portion thereof, or to accept an alternate bid/proposal. The City of Elsmere reserves the right to waive any immaterial defect in any bid. The City of Elsmere may seek clarification from any bidder/offeror at any time and failure to respond promptly is cause for rejection of a bid.
- 7. **INCURRED COSTS** The City of Elsmere will not be liable for any costs incurred by bidders/offers in replying to this Request for Bids/Proposals.
- 8. **AWARD** It is the intent of the City of Elsmere to award a contract to the lowest evaluated bidder/offeror meeting specifications. The City of Elsmere reserves the right to determine the lowest evaluated/responsible bid/offer on the basis of an individual item, groups of items, or in any way determined to be in the best interests of the City of Elsmere. Award will be based on the following factors (where applicable): (a) adherence to all conditions and requirements of the bid/proposal specifications; (b) price; (c) qualifications of the bidder/offeror, including past performance, financial responsibility, general reputation, experience, service capabilities, and facilities; (d) delivery or completion date; (e) product appearance, workmanship, finish, taste, feel, overall quality, and results of product testing; (f) maintenance costs and warranty provisions; and (g) repurchase or residual value. Bids/proposals accepted by Elsmere may be made available to all local municipalities in Boone, Campbell and Kenton Counties upon request.

- 9. **PRICING** The price quoted for each item is the full purchase price, including delivery to destination, and includes all transportation and handling charges, premiums on bonds, material or service costs, patent royalties and all other overhead charges of every kind and nature. Unless otherwise specified, prices shall remain firm for the contract period.
- 10. **DISCOUNTS** Prices quoted must be net after deducing all trade and quantity discounts. Where cash discounts for prompt payment are offered, the discount period shall begin with the date of receipt of a correct invoice or receipt or final acceptance of goods, whichever is later.
- 11. **OCCUPATIONAL LICENSES** The City of Elsmere reserves the right to reject any bids/offers from Bidders/Offerors that are not in compliance with Kenton County or Elsmere's Occupational License Ordinances.
- 12. **TAXES** Elsmere is not subject to Federal Excise tax. Per Kentucky Administrative Regulation 103 KAR 30:225E, Elsmere is exempt from state and local taxes.
- SPECIFICATIONS Reference to brand names and numbers is descriptive, but not restrictive, unless otherwise specified. Bids/Proposals on equivalent items will be considered, provided the bidder/offeror clearly states exactly what is proposed to be furnished, including complete specifications. Unless the bidder/offeror specified otherwise, it is understood the bidder/offeror is offering a referenced brand item as specified or is bidding/offering as specified when no referenced, and does not propose to furnish an "equal." Elsmere reserves the right to determine whether a substitute offer is equivalent to and meets the standard of quality indicated by the brand name and number.
- 14. **SAMPLES** Samples of items, when called for, must be furnished free of expense and, if not destroyed in the evaluation process, will, upon request, be returned at the vendor's expense. Request for the return of samples must accompany the sample and include UPS Pickup Slip, postage or other acceptable mode of return. Individual samples must be labeled with bidder/offeror's name, item reference, manufacturer's brand name and number.
- 15. **INTERPRETATION OR CORRECTION OF BIDDING DOCUMENTS** Bidder/Offerors shall promptly notify Elsmere of any ambiguity, inconsistency or error which they may discover upon examination of the bidding documents. Interpretations, corrections and changes will be made by addendum. Each bidder/offeror shall ascertain prior to submitting a bid that all addenda have been received and acknowledged in the bid.
- 16. **VARIANCES** State or list by reference on the reverse side of the Bid/Proposal form or on a separate sheet of paper any variations to specifications, terms and/or conditions.
- 17. **INDEMNIFICATION** The Seller/Bidder shall indemnify and hold harmless the City of Elsmere, its agents, officials, and employees from and against all injuries, losses, claims, suits, costs and expenses which may accrue against the City of Elsmere as a consequence of granting a contract or that result from this bidding process.
- 18. **DEFAULT** Time is of the essence as applicable to this contract and if delivery of acceptable items or rendering of services is not completed by the time promised, Elsmere reserves the right, without liability, in addition to its other rights and remedies, to terminate the contract by notice effective when received by Seller/Bidder, as to stated items not yet shipped or services not yet rendered and to purchase substitute items or services elsewhere and charge the Seller with any or all losses incurred. Elsmere shall be entitled to recover its attorney's fees and expenses in any successful action by the Elsmere to enforce any resulting contract.

- 19. **INSPECTION** Materials or equipment purchased are subject to inspection and approval at a destination specified by Elsmere. Elsmere reserves the right to reject and refuse acceptance of items which are not in accordance with the instructions, specifications, drawings or data of Seller's warranty (express or implied). Rejected materials or equipment shall be removed by, or at the expense or, the seller promptly after rejection.
- 20. WARRANTY Seller warrants that all goods and services furnished hereunder will conform in all respects to the terms of this solicitation, including any drawings, specifications or standards incorporated herein, and that they will be free from latent and patent defects in materials, workmanship and title, and will be free from such defects in design. In addition, Seller warrants that said goods and services are suitable for, and will perform in accordance with, the purposes for which they are purchased, fabricated, manufactured and designed or for such other purposes as are expressly specified in this solicitation. Elsmere may return any nonconforming or defective items to the Seller or require correction or replacement of the item at the time the defect is discovered, all at the Seller's risk and expense. Acceptance shall not relieve the Seller of its responsibility.
- 21. **REGULATORY COMPLIANCE** Seller/Bidder represents and warrants that the goods or services furnished hereunder (including all labels, packages and container for said goods) comply with all applicable standards, rules and regulations in effect under the requirements of all Federal, State and local laws, rules and regulations as applicable, including the Occupational Safety and Health Act as amended, with respect to design, construction, manufacture or use for their intended purpose of said goods or services. Seller shall furnish "Material Safety Data Sheets" on all chemicals.
- 22. **EQUAL EMPLOYMENT OPPORTUNITY** Contractor shall comply with the Kentucky Human Rights Act, HRA 344.150 344.270 as amended and any rules and regulations promulgated in accordance therewith, including, but not limited to the Equal Employment Opportunity EEO 45.550 45.640 which is incorporated herein by reference. Furthermore, the Contractor shall comply with the Employment Discrimination Act, EDA 344.040, 344.050 as amended.
- 23. **ROYALTIES AND PATENTS** Seller shall pay all royalties and license fees. Seller shall defend all suits or claims for infringement of any patent, copyright or trademark rights and shall hold the City Of Elsmere harmless from loss on account thereof.
- 24. **LAW GOVERNING** Any resulting contract shall be governed by and construed according to the laws of the Commonwealth of Kentucky. Pursuant to the provisions of KRS 45A.343, the contractor or vendor is required to reveal to Elsmere any final determination of a violation of KRS Chapters 136, 139, 141, 337, 338 and 342 by the contractor or vendor within the previous five (5) years; and further that said contractor or vendor has been and is in continuous compliance with the provisions of KRS Chapters 136, 139, 141, 337, 341, and 342 for the duration of the contract. The failure of a contractor or vendor to reveal a final determination of a violation to a local government, or to comply with the statutory requirements, is considered grounds for cancellation of a contract and disqualification of the contractor or vendor from eligibility for any Elsmere contracts for a period of two (2) years.
- 25. **LIABILITY INSURANCE** Unless otherwise provided herein, liability insurance in the amount of \$1,000,000.00 must be maintained through out the life of the contract. A Certificate of Insurance naming Elsmere as co-insured or additional insured must be submitted prior to execution of the Contract. The policy must provide that Elsmere (as co-insured) shall be given at least a 10 day advance written notice of any proposed cancellation or termination of the policy.

The Vendor shall make delivery within one hundred twenty (120) days of receipt of the City of Elsmere's purchase order, which may be modified at the sole discretion of the designated City of Elsmere official for circumstances beyond control of the Vendor.
- 2) Bids accepted by the City of Elsmere may be made available to all members of the Northern Kentucky Governmental Purchasing Association. The City of Elsmere reserves the right to reject any and all bids, to waive formalities, and to negotiate

with the apparent qualified bidder to such an extent as may be determined by Elsmere, even though such bid may not, on its face, appear to be the lowest and best price.
